- Voluntary—greater of 25% or 10 eligible enrolled

Standard Features

- Accelerated death benefit (living benefit): Employees who are given a terminal diagnosis can receive 50% while they are still living.
- Premium waiver: Coverage may continue without premium payment if the employee becomes disabled prior to age 60.
- Conversion privilege: Employees/Dependents may apply to convert all or part of their group life insurance to an individual policy, if they terminate employment or are no longer eligible for coverage.
- Portability (voluntary product): The option to continue a portion or all of their life insurance coverage when employees leave employment.
- Employers can offer Basic and/or Voluntary Term Life coverage as a stand-alone plan or as an addition to another Blue Cross plan.
- Dependent Life benefits: \$5,000 spouse/\$2,500 child or \$10,000 spouse/\$5,000 child.
